On the T - Bills auction without foreign exchange clause, code DZ2015/05 - 364, held on March 10, 2015, amount of Denar 4.666.000.000 was offered for treasury bills with maturity of 364 days. The demand for the 12-month treasury bills amounted to Denar 4.666.000.000 and the amount realized was Denar 4.666.000.000. Looking at the ownership structure of the 12-month treasury bills without foreign exchange clause issued on March 10, 2015, banks participate with 76,42%, while the clients with 23,58%.
