On the T-Bills auction with foreign exchange clause, code DZ2009/03-357dk, held on 23 June 2009, **amount** of Denar 1.000.000.000 was **offered** for treasury bills with maturity of 357 days. The **demand** for the 12-month treasury bills amounted to Denar 1.453.350.000, and the **amount realized** was Denar 1.000.000.000. Looking at the **ownership structure of the 12-month treasury bills with foreign exchange clause** issued on 23 June 2009, clients participate with 4,02%, whilst the banks with 95,98%. The stock of **government securities** as of 23 June 2009, is Denar 9.558.200.000 out of which Denar 2.000.020.000 refers to government securities with foreign exchange clause only. The stock of 12-month T-bills is Denar 1.632.980.000 out of which Denar 1.350.020.000 refers to 12-month T-bills with foreign exchange clause only.
