On the T - Bonds auction with EUR clause, code DO2013/12 - 0518dk, held on 07 May 2013, amount of Denar 465.000.000 was offered for treasury bills with maturity of 5 years. The demand for the 5 - year treasury bonds amounted to Denar 432.500.000, and the amount realized was Denar 432.500.000. Looking at the ownership structure of the 5 - year treasury bonds with EUR clause issued on 07 May 2013, clients participate with 100%, whilst the banks with 0%.
