On the T - Bonds auction with EUR clause, code DO2013/16 - 0618dk, held on 18 June 2013, amount of Denar 65.000.000 was offered for treasury bonds with maturity of 5 years. The demand for the 5 - year treasury bonds amounted to Denar 47.200.000, and the amount realized was Denar 47.200.000. Looking at the ownership structure of the 5 - year treasury bonds with EUR clause issued on 18 June 2013, clients participate with 100%, whilst the banks with 0%.
