On the T-Bills auction without foreign exchange clause, code DZ2011/04 - 99, held on 22 March 2011, **amount** of Denar 900.000.000 was **offered** for treasury bills with maturity of 99 days. The **demand** for the 3 - month treasury bills amounted to Denar 900.000.000, and the **amount realized** was Denar 900.000.000. Looking at the **ownership structure of the 3 - month treasury bills without foreign exchange clause** issued on 22 March 2011, clients participate with 0%, whilst the banks with 100%.
