On the T-Bills auction with foreign exchange clause, code DZ2011/17 – 91 dk, held on 05 July 2011, **amount** of Denar 670.000.000 was **offered** for treasury bills with maturity of 91 days. The **demand** for the 3-month treasury bills amounted to Denar 670.000.000, and the **amount realized** was Denar 670.000.000. Looking at the **ownership structure of the 3-month treasury bills with foreign exchange clause** issued on 05 July 2011, clients participate with 52,24%, whilst the banks with 47,76%.
