On the T-Bills auction without foreign exchange clause, code DZ2011/21 - 91, held on 01 August 2011, **amount** of Denar 2.100.000.000 was **offered** for treasury bills with maturity of 91 days. The **demand** for the 3 - month treasury bills amounted to Denar 1.645.000.000, and the **amount realized** was Denar 1.645.000.000. Looking at the **ownership structure of the 3 - month treasury bills without foreign exchange clause** issued on 01 August 2011, clients participate with 4,56%, whilst the banks with 95,44%.
