On the T-Bills auction with foreign exchange clause, code DZ2012/04 - 91 dk, held on 17 January 2012, **amount** of Denar 1.800.000.000 was **offered** for treasury bills with maturity of 91 days. The **demand** for the 3-month treasury bills amounted to Denar 1.295.390.000, and the **amount realized** was Denar 1.295.390.000. Looking at the **ownership structure of the 3-month treasury bills with foreign exchange clause** issued on 17 January 2012, clients participate with 1.57%, whilst the banks with 98.43%.
