On the T-Bills auction without foreign exchange clause, code DZ2013/07 - 84, held on 19 February 2013, **amount** of Denar 2.250.000.000 was **offered** for treasury bills with maturity of 84 days. The **demand** for the 3 - month treasury bills amounted to Denar 4.006.080.000, and the **amount realized** was Denar 2.250.000.000. Looking at the **ownership structure of the 3 - month treasury bills without foreign exchange clause** issued on 19 February 2013, clients participate with 1.15%, whilst the banks with 98.85%.
