On the T - Bills auction without foreign exchange clause, code DZ2013/19 - 364, held on 3 December 2013, amount of Denar 800,000,000 was offered for treasury bills with maturity of 364 days. The demand for the 12 - month treasury bills amounted to Denar 766,610,000 and the amount realized was Denar 766,610,000. Looking at the ownership structure of the 12 - month treasury bills without foreign exchange clause issued on 3 December 2013, clients participate with 4.78%, whilst the banks with 95.22%.
