Law amending the Law on Borrowing a Loan by the Republic of Macedonia from the Council of Europe Development Bank under the Framework Loan Agreement for financing the Project for Consolidation and Modernisation of “Mother Teresa” Clinical Centre in Skopje and Regional Clinical Hospital in Shtip,

**LAW AMENDING THE LAW ON BORROWING A LOAN BY THE REPUBLIC OF MACEDONIA FROM THE COUNCIL OF EUROPE DEVELOPMENT BANK UNDER THE FRAMEWORK LOAN AGREEMENT FOR FINANCING THE PROJECT FOR CONSOLIDATION AND MODERNISATION OF “MOTHER TERESA” CLINICAL CENTRE IN SKOPJE AND REGIONAL CLINICAL HOSPITAL IN SH TIP**

**Article 1**

The wording “Mother Teresa Clinical Center in Skopje” in the title of the Law on Borrowing a Loan by the Republic of Macedonia from the Council of Europe Development Bank under the Framework Loan Agreement for financing the Project for Consolidation and Modernisation of “Mother Teresa” Clinical Centre in Skopje and Regional Clinical Hospital in Shtip (“Official Gazette of the Republic of Macedonia”, no. 98 / 15) shall be deleted.

## **Article 2**

The amount “97,000,000” in Article 1 shall be replaced by the amount “26,937,458“, and the wording: “Mother Teresa Clinical Centre in Skopje and“ shall be deleted.

## **Article 3**

The wording “Mother Teresa Clinical Centre in Skopje and“ in paragraphs 1 and 2 in Article 2 and Article 5 shall to be deleted.

## **Article 4**

This Law shall enter into force on the day it is published in the “Official Gazette of the Republic of Macedonia”.
