**LAW ON ADDENDUM TO THE LAW ON BORROWING A LOAN BY THE REPUBLIC OF MACEDONIA AT THE EUROPEAN BANK FOR RECONSTRUCTION AND DEVELOPMENT UNDER THE LOAN AGREEMENT FOR FINANCING THE PROJECT “CONSTRUCTION OF NEW AND RECONSTRUCTION OF THE EXISTING PARTS OF THE SECTION BELJAKOVCE KRIVA PALANKA – EASTERN PART OF RAIL CORRIDOR VIII, PHASE 2“**

Article 1

As for the Law on Borrowing a Loan by the Republic of Macedonia at the European Bank for Reconstruction and Development under the Loan Agreement for Financing the Project “Construction of New and Reconstruction of the Existing Parts of the Section

Beljakovce-Kriva Palanka – Eastern Part of Rail Corridor VIII, Phase 2“, („Official Gazette of the Republic of Macedonia“, no. 178/14“), Article 7-a shall be added after Article 7 and shall read:

"Article 7-a

Supply of goods and services to the Public Enterprise Macedonian Railway Infrastructure – Skopje intended for implementation of the Project “Construction of New and Reconstruction of the Existing Parts of the Section Beljakovce - Kriva Palanka – Eastern Part of Rail Corridor VIII, Phase 2“, financed under the Loan Agreement referred to in Article 1 of this Law, shall be exempt from value added tax with the right to tax credit deduction.

Import of goods by the Public Enterprise Macedonian Railway Infrastructure – Skopje intended for implementation of the Project “Construction of New and Reconstruction of the Existing Parts of the Section Beljakovce - Kriva Palanka – Eastern Part of Rail Corridor VIII, Phase 2“, financed under the Loan Agreement referred to in Article 1 of this Law, shall be exempt from value added tax and customs duties, as well as excise duties, when importing passenger vehicles and mineral oils.

Supply rendered to the Public Enterprise Macedonian Railway Infrastructure – Skopje for the purposes related to implementation of the Project “Construction of New and Reconstruction of the Existing Parts of the Section Beljakovce - Kriva Palanka – Eastern Part of Rail Corridor VIII, Phase 2“, financed under the Loan Agreement referred to in Article 1 of this Law, the Public Enterprise being a tax debtor pursuant to point 4, Article 32 and Article 32-a of the Law on Value Added Tax, shall be exempt from the obligation to calculate and pay the value added tax.

Taxpayer performing VAT-exempt supply pursuant to paragraph (1) of this Article shall mandatory indicate the name of the project and the name of the Loan Agreement referred to in Article 1 of this Law in the invoice, in addition to the name (title) of the recipient of the good or the user of the service.

When importing the goods exempted pursuant to paragraph (2) of this Article, Public Enterprise Macedonian Railway Infrastructure – Skopje shall mandatory submit copy of the Loan Agreement referred to in Article 1 of this Law and a statement that the imported goods/services are intended for realization of the Project “Construction of New and Reconstruction of the Existing Parts of the Section Beljakovce- Kriva Palanka – Eastern Part of Rail Corridor VIII, Phase 2“, financed under the Loan Agreement referred to in Article 1 of this Law, to the competent customs authority."

Article 7

This Law shall enter into force on the day it is published in the “Official Gazette of the Republic of Macedonia”.
